

## *Notes to the Contributors*

1. We look forward only for the original articles and we reserve our right to reject any articles without any specific reason. All articles and reviews are submitted to a peer review.
2. An article is reviewed for publication assuming that its contents have not been submitted simultaneously to another journal, have not been accepted for publication elsewhere and have not already been published. Any attempt at dual publication will lead to automatic rejection and may prejudice acceptance of future submissions.
3. Articles should be abridged, briefly styled and it should not exceed 8000 words. It should have a brief summary of the theme first (abstract) and the text be detached by specific paragraphs and captions. Illustrations and charts should be separately marked and identified.
4. The references and citations be given at the end of the text and the style and standard developed by MLA Handbook for writers of Research papers (Joseph Gibaldi) be followed.
5. E-mail your complete manuscripts as a single word file or PDF format accompanied by a covering letter, to the editor at for peer review and following its clearance, ( which will be done within eight weeks ) send two hard copies of original articles in Black and White along with its softcopy version in IBM compatible Compact Disk to the office of the editor in advance.
6. We do not limit the areas of investigation and any area is a positive welcome. For your information we would set pages carrying the following themes:  
**History & Culture, Medicine & Health care, Science & Technology, War & Terrorism, Theories of Human Rights, Agriculture, Tourism and Environment, Economics, Development & Poverty, UN, Law & Society, Women, Children and Minorities, Refugees, Oppressed, Dalits and ethnic conflicts**
7. A covering letter (letters) must accompany all submissions and it be signed by all authors. All sorts of commitments and financial assistance received should be specified in the covering letter itself. The first named author is responsible for ensuring that all authors have seen, approved and are fully conversant with its contents.
8. Authors are requested to send their brief bio-data along with their submissions in the CD.
